



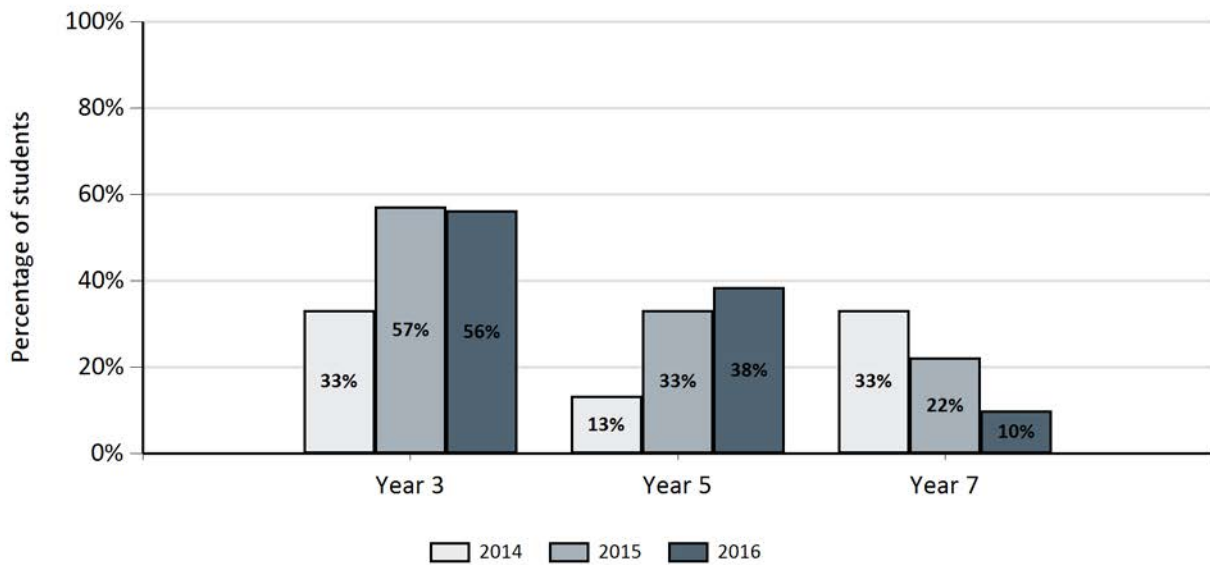

NAPLAN Proficiency

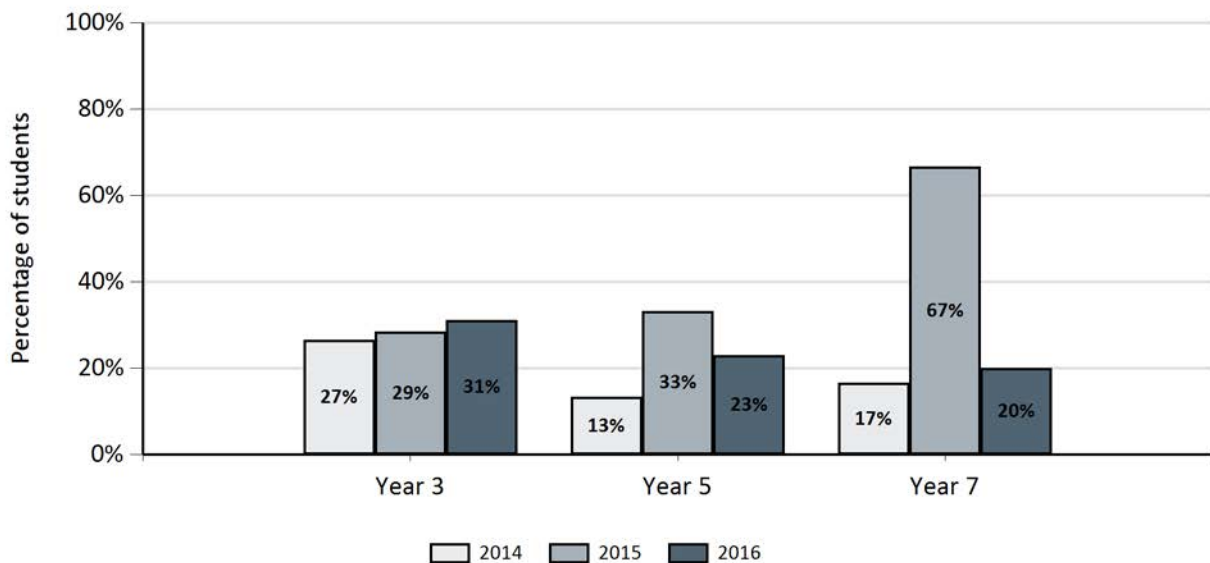
